- 3. All fresh candidates are required to deposit non-refundable application fee of Rs. 4000/- (Rs. 3000/- for SC, ST, ST-STA category candidate of Rajasthan state domicile) + applicable transaction charges.
- 4. The last date of Resignation, without forfeiture of security amount, for Round 1 joined candidates who did not get upgraded, in round 2, shall be 29.07.2025 by 5:00 pm, after this date and time no resignation shall be allowed and rules will be applicable accordingly.
