**State Dental P.G. Seats (MDS) Round 2 Allotments-2025**

In continuation to the earlier notifications, the round 2 online-allotment procedure for PG Dental courses (MDS) will be carried out as per schedule given below:

**Schedule for Allotment Process - Round 2**

<b><u>Application form (Registration)</u></b> Start date for filling of on-line application form and deposition of required application fee  <b>It is a mandatory step for subsequent process of counseling and allotment.</b>  <b>Both the parts (Part 1 and Part 2) of the application form must be filled and completed.</b>  <b>Candidates who could not complete both the parts (Part 1 and Part 2) of the application form earlier, may also complete the same.</b>  <b>Those who are already registered/have applied need not register/apply again.</b>	16.07.2025

Earlier registered candidates who did not get allotment in Round 1 OR got allotment in Round 1 but did not join or resigned after joining 2. Joined candidates of Round 1 who wish to upgrade 3. 1. Refer information booklet, college information sheet and college fee structure etc. and other information at the website. Regarding fee, also refer order dated 19.05.2022 of Hon'ble Supreme Court in civil appeal no. 3978-3995/2017.
2. **All PwD candidates** must present themselves physically for document verification before the admission board on 21.07.2025 as per the notification and the list to be made available at the website.
3. All fresh candidates are required to deposit non-refundable application fee of Rs. 4000/- (Rs. 3000/- for SC, ST, ST-STA category candidate of Rajasthan state domicile) + applicable transaction charges.
4. The last date of Resignation, without forfeiture of security amount, for Round 1 joined candidates who did not get upgraded, in round 2, shall be 29.07.2025 by 5:00 pm, after this date and time no resignation shall be allowed and rules will be applicable accordingly.
5. The candidates are advised to visit the websites regularly for registration and other relevant information.

**Important: For candidates willing to participate/upgrade in Round 2, it is mandatory to fill fresh choices in Round 2 (irrespective of whether the candidate was allotted/joined a seat in Round 1 or not).**

**The choices filled by candidate in Round 1 shall be scraped off and will not be considered for Round 2. If a candidate does not fill fresh choices for Round 2, then he/she will not be considered for allotment/upgradation in Round 2.**
